Subject: Suspension of Registration of Dr Ummer Farooq Bhat, S/o Farooq Ahmad Bhat R/o Bugam Kulgam and presently residing at Sheeren Bagh, Srinagar, J&K under V(2) of Terms of Reference of S.O. 362 dated 20-10-2021, read with Clause 8.1 of Chapter 8 of the IMC (Professional Conduct, Etiquette and Ethics) Regulations, 2002 and Rule V(5) of the J&K Medical Council – Code of Medical Ethics.

Reference: FIR No. 05/2025 under sections 196,152 and 351 (2) of the Bharatiya Nyaya Sanhita (BNS) and section 13 of the unlawful activities (Prevention) Act.

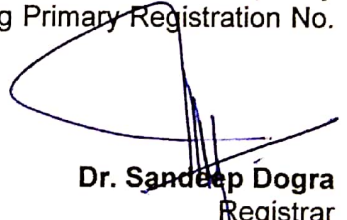
Whereas Dr Ummer Farooq Bhat, J&K having Primary Registration No. 16777 (2020) with the Jammu & Kashmir Medical Council has been detained by CIK, Police Station Srinagar, in connection with FIR No. 05/2025 under sections 196,152 and 351 (2) of the Bharatiya Nyaya Sanhita (BNS) and section 13 of the unlawful activities (Prevention) Act.

And whereas such conduct is prima facie inconsistent with the standards of ethical propriety, integrity and public trust expected of members of medical profession and attracts the provisions of Clause 801 of chapter 8 of the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002, which mandates that: "A physician shall uphold the dignity and honor of his profession and the prime object of the medical profession is to render service to humanity; reward or financial gain is a subordinate consideration."

Further, rule V(5) of the J&K Medical Council – Code of Medical Ethics obligates every registered medical practitioner to maintain conduct consistent with human values, public confidence and the moral integrity of the profession.

Now, therefore, in exercise of the powers conferred under V(2) of Terms of Reference of S.O. 362 dated 20-10-2021, the Jammu & Kashmir Medical Council hereby orders the temporary suspension of medical registration of Dr Ummer Farooq Bhat, J&K having Primary Registration No. 16777 (2020) till further orders.
